

ALLERGEN INFORMATION

ALLERGENS

Our manufacturing site does not use peanuts or tree nuts.

The following allergens are present, and a control process is in place to prevent cross-contamination:

- Eggs
- Milk
- Fish
- Crustaceans
- Soybeans
- Wheat (controlled as gluten)

EU and Canada specific allergens are also present, and a control process is in place to prevent cross-contamination:

- Celery
- Mustard
- Sesame seed
- Sulfites

ALLERGENS IN PRODUCTION PROCESS

Raw materials used in the production of food are reviewed to determine if allergens are present. Allergens are considered when conducting a hazard analysis for any product. Labels are to be reviewed during the HACCP process to ensure that all allergens are properly stated on the label. To avoid cross-contact, the following steps are observed:

- Manufacturing process utilizes batch production rather than continuous lines.
- Production equipment is designed to allow complete cleaning.
- All equipment, tools, and accessories used to produce materials containing allergens shall be cleaned prior to use for production of any other products. Color-coded scopes are used based on the type of allergen.
- Employees handling allergens will wear a color-coded protective smock when mixing formulations that contain an allergen.
- R&D will list FDA, EU, and Canadian allergens on raw product specification sheets and process formulas.
- Containers that are used to process or hold materials with allergens are tracked and labeled with the name of the allergen.
- A procedure is in place to rework a product containing an allergen.
